

**CHARTER TOWNSHIP OF WHITE LAKE
Notice of Consideration**

**Ordinance No. 133
Ordinance to Confirm the Establishment of a Planning Commission**

Notice is hereby given that at a regular board meeting on October 18, 2011 the Charter Township of White Lake accepted White Lake Township Ordinance No 133, Ordinance to Confirm the Establishment of a Planning Commission, with final consideration to be made at the November 15, 2011 regular board meeting.

An ordinance to confirm the establishment of the Charter Township of White Lake Planning Commission, under the Michigan Planning Enabling Act, Public Act 33 of 2008, MCL 125.3801, et seq.; to provide for the composition of that Planning Commission; to provide for the powers, duties and limitations of that Planning Commission; and to repeal any ordinance or parts of ordinances or resolutions in conflict with this ordinance.

THE CHARTER TOWNSHIP OF WHITE LAKE, OAKLAND COUNTY, MICHIGAN, ORDAINS:

Section 1: Scope, Purpose and Intent

1. This ordinance is adopted pursuant to the authority granted the Township Board under the Michigan Planning Enabling Act, Public Act 33 of 2008, MCL 125.3801, et seq., and the Michigan Zoning Enabling Act, Public Act 110 of 2006, MCL 125.3101, et seq., to establish a Planning Commission with the powers, duties and limitations provided by those Acts and subject to the terms and conditions of this ordinance and any future amendments to this ordinance.
2. The purpose of this ordinance is to provide that the Charter Township of White Lake Board shall hereby confirm the establishment under the Michigan Planning Enabling Act, Public Act 33 of 2008, MCL 125.3801, et seq., of the Charter Township of White Lake Planning Commission formerly established under the Township Planning Act, Public Act 168 of 1959, MCL 125.321, et seq.

Section 2: Establishment

The Township Board hereby confirms the establishment of the Charter Township of White Lake Planning Commission under the Michigan Planning Enabling Act, Public Act 33 of 2008, MCL

125.3801, et seq., formerly established under the Township Planning Act, Public Act 168 of 1959, MCL 125.321, et seq.

Members of the Charter Township of White Lake Planning Commission as of the effective date of this Ordinance, except for an ex officio member whose remaining term on the Planning Commission shall be limited to his or her term on the Township Board, shall continue to serve for the remainder of their existing terms so long as they continue to meet all of the eligibility requirements for Planning Commission membership set forth within the Michigan Planning Enabling Act, Public Act 33 of 2008, MCL 125.3801, et seq.

Section 3: Severability

The provisions of this ordinance are hereby declared to be severable, and if any part is declared invalid for any reason by a court of competent jurisdiction, it shall not affect the remainder of the ordinance, which shall continue in full force and effect.

Section 4: Repeal

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed. The resolution or ordinance establishing the Charter Township of White Lake Planning Commission under the Township Planning Act, Public Act 168 of 1959, MCL 125.321, et seq., is hereby repealed.

Section 5: Effective Date

This ordinance shall take effect immediately after the ordinance is published in a newspaper of general circulation in the township.
