All applicants submitting for a commercial permit must submit the following:

- Approved site plan
- Soil Erosion permit or waiver
- Approved septic permit from OCHD or an approval from WLT DPS Director
- Approved well permit from OCHD or water hook up through WLT DPS Director

- Third party inspections list including names, addresses and phone numbers of the third party inspectors
 - Concrete
 - Steel (fabricator, welding, high strength bolts)
 - Soils
 - Masonry walls
 - Under slab compaction and re-enforcement
 - Pile foundations
 - Pier foundations
 - Wood construction
 - Fire Suppression submittals

- Fire Alarm submittals
- Architect and Engineers names, addresses and phone numbers
- Contractor's name, address and phone number
- Name, address and phone number of the Designated Design Professionals in charge of the project
- Name, address and phone number of the contact person in charge of the project
- Completed building permit application with 1-set of complete construction plans **AND** digital plans
