- Swimming Pool Permit Application
- Grading and Drainage Application
- Building and Zoning Permit Regulations form
- Provide 2 sets of detailed construction plans
- Provide 2 sets of detailed plot plans showing proposed location of pool
- Provide a Soil Erosion Permit. The pool permit will not be issued prior to obtaining a Soil Erosion permit or waiver. **Soil Erosion Control Permit must be applied for at Oakland County WRC, One Public Works Drive, Building 95W, Waterford, MI. (248) 858-5389. www.oakgov.com/water**
- Applicant/Homeowner responsible for property lines

Final inspection is required.

Permits are required for electrical and fence in order to obtain pool permit.

BUILDING AND ZONING PERMIT REGULATIONS

1. A Certificate of Occupancy must be obtained before occupying the building.
2. Additional permits are required for HVAC, Plumbing, Electrical, Fireplaces, Pools, Fences and Decks.
3. Three (3) site plans and three (3) sets of construction plans with sectionals are required to be submitted with the building application.
4. The Builder and property owner are responsible for drainage and grade on the construction site.
5. The Builder and property owner are responsible for lot line and proper setbacks as approved by White Lake Township.
6. The lot is properly marked (properly marked is a visible address with the lot number and permit number that can be clearly seen from the road).
7. The job site must be clean with a safe access for the inspectors.
8. The road must be cleaned and maintained properly (this includes snow removal).
