CHARTER TOWNSHIP INCORPORATION RESOLUTION

WHEREAS White Lake Township was heretofore notified by the Secretary of State of Michigan that it had obtained a population in excess of 5,000 and, accordingly, was eligible to become a Charter Township, and

WHEREAS in accordance with the Charter Township Act of the State of Michigan, a notice was published concerning the rights of the Township citizens with respect to Charter Township incorporation on September 18 and September 25, 1985, including the intention of the Township to adopt a final resolution of incorporation as a Charter Township, and

WHEREAS more than 60 days have elapsed since the adoption of said resolution on intent and no petition of disagreement to such incorporation has been filed with the Township, as authorized in said statute;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Township of White Lake, Oakland County, Michigan, being qualified and having completed all necessary action preliminary thereto, does hereby incorporate as the Charter Township of White Lake, Oakland County, Michigan, pursuant to 1947 PA 359, as amended, which Act shall constitute the charter of said Township.

BE IT FURTHER RESOLVED that the Charter Township of White Lake, Oakland County, Michigan, shall, as provided by law, succeed to and be vested with all the property, real and personal, money, rights, credits and causes of action belonging to White Lake Township, also known as the Charter Township of White Lake as it formerly existed and that all taxes and assessments levied and uncollected as of the date of this resolution of incorporation shall remain in full force and effect until discharged or collected.

BE IT FURTHER RESOLVED that the Clerk of said Township cause a certified copy of the within resolution, a certified copy of the resolution of intent to incorporate, and affidavits of the publication of such notice and resolution to be forthwith filed with the Oakland County Clerk and the Secretary of State of Michigan as notice of the within incorporation.

BE IT FURTHER RESOLVED that the within Charter Township incorporation take effect as of this date.


