## **REQUIRED MINIMUM ENTRANCE QUALIFICATIONS**

## AT THE TIME OF APPLICATION, AN APPLICANT MUST:

- 1. Be a citizen of the United States.
- 2. Have earned a high school diploma or equivalent GED; associate's or bachelor's degree from accredited college will receive preference.
- 3. Have earned a current Michigan operator's or chauffeur's license.
- 4. Have earned a certificate of training for Firefighter II as recognized by the Michigan Firefighters Training Council at time of conditional job offer.
- 5. Have a current Michigan EMT (Emergency Medical Technician) license at time of conditional job offer. State licensed (Michigan or National Registry) Paramedic is preferred. New hires will be required to complete a sponsored Paramedic program, and licensure within 2 years from date of hire (based on class availability).
- 6. Submit a copy of the following documents. These documents <u>must</u> accompany the completed application:
  - a. Valid high school diploma.
  - b. Valid Michigan operator's or chauffer's license.
  - c. Valid Michigan EMT license at time of conditional offer.
  - d. Valid Firefighter I and II Michigan certification at time of conditional offer.
  - e. CPAT (Candidate Physical Ability Test), or OPAT (Oakland Physical Agility Test) certificate at time of conditional offer.

Notes: Failure to provide documentation may be cause for disqualification.

- 7. Be aware, a copy of the following is optional to accompany the application:
  - a. College transcripts and diploma.
  - b. Resume.
  - c. Fire Officer certifications or any other related medical or firefighter training certificates.

- 9. Have normal hearing in each ear.
- 10. Have a good driving record.
