# D. PROCLAMATION - BOY SCOUT TROOP #113 - 50<sup>TH</sup> ANNIVERSARY

Supervisor Baroni read into the record a Proclamation honoring Boy Scout Troop #113 on their 50<sup>th</sup> Anniversary.

Supervisor Baroni introduced Adam Kline as the new Chief of Police for White Lake Township. He has been with the force 26 years.

#### E. PLANTE MORAN - 2013 AUDIT RESULTS AND FINANCIAL STATEMENTS

Les Pulver, auditor partner with Plante Moran, presented the board members the results of the 2013 audit and financial statements. A summary letter was presented to the Board stating the results of the audit. The financial statements were accurate and clear and prepared in accordance with the rules. There were no disagreements with management, no unreported items found, no difficulties in doing the audit. There were no internal control weaknesses found this year which is evidence of a good system of checks and balances and a good job by the accounting department.

Pam Hill, senior manager, presented the Board with graphs showing the finances of the township in an overview fashion. Two main sources of revenue for the Township in the General Fund is state shared revenue which has gone up approximately 5% from last year. The second largest source of revenue is property tax revenue which over the last five years has significantly declined. This is the most significant source of revenue for the police and fire funds. Without a millage renewal, you will not be able to continue with the public safety services which are currently provided. The Township has done a really good job of watching the expenditures and has been very fiscally responsible.

Supervisor Baroni mentioned that it was a great honor for staff member, Elaine Homeister, to be asked to be a presenter and co-instructor at a session held by the Michigan Government Finance Officers Association. He also congratulated Mr. Pulver who will be retiring this year after 40 years of service. For any residents who would like to view the audit information, it will be available on the web site as well as at the Township offices.

Trustee Burkard, as of last month, has now served the Township for 25 years. The day she was sworn in, she went from being a displaced homemaker to a public servant. At that time, she felt it was the biggest honor to represent the people of this township and has never lost that feeling.

Chief Gurka, Fire Department, presented a citizens award and Supervisor Baroni read into the record

During this past ski season, a young boy slipped out of his chair on the ski lift. He was able to grab onto the chair and was hanging precariously 40 feet up in the air. Ms. Lee climbed up the pole. Mr. Shones steadied the chair for Ms. Lee to be able to climb onto the chair, reach down and pull the boy to safety. Ms. Lee accepted the citizen's award and proclamation for Mr. Shones as he was not able to be present at tonight's meeting.

# C. RESOLUTION #2014-014, TO APPROVE POLICE MILLAGE BALLOT LANGUAGE PROPOSAL

Clerk Lilley strongly recommended making sure the citizens are well aware of the fact that even though property values are rising, it is not enough to keep pace with the expenses. The current recommended millage increase is .50 cents for every \$1000 of home valuation. On a home with a State Equalized Value of \$100,000 the cost would be approximately \$50 a year.

It was MOVED by Clerk Lilley, SUPPORTED by Trustee Voorheis, to approve Resolution #2014-014, to Approve Police Millage Ballot Language Proposal. The MOTION PASSED by a voice vote (6 yes votes).

D. RESOLUTION #2014-015, TO APPROVE FIRE MILLAGE BALLOT LANGUAGE PROPOSAL

It was MOVED by Trustee Ruggles, SUPPORTED by Trustee Kowall, to approve Resolution #2014-015, to Approve Fire Millage Ballot Language Proposal. The MOTION PASSED with a voice vote (6 yes votes).

# A. SECOND READING, ORDINANCE 2014-001 - ORDINANCE ADOPTING AND ENACTING THE CODE OF ORDINANCES

It was MOVED by Trustee Burkard, SUPPORTED by Trustee Kowall to approve Ordinance 2014-001, Ordinance Adopting and Enacting the Code of Ordinances. The MOTION PASSED by a voice vote (6 yes votes).

B. SECOND READING, ORDINANCE 2014-002 - ORDINANCE AMENDMENT TO ORDINANCE 32-A

It was MOVED by Trustee Burkard, SUPPORTED by Trustee Ruggles to approve Ordinance 2014-002, Ordinance Amendment to Ordinance 32-A. The MOTION PASSED by a voice vote (6 yes votes).

### C. TOWNSHIP HALL - PHASE 1 BID RESULTS

It was MOVED by Clerk Lilley, SUPPORTED by Trustee Kowall to approve \$400,000 for the Township Hall - Phase 1 Bid Results with J&A to supply a complete set of drawings for the additional parking and the retention area. The MOTION PASSED by a voice vote (6 yes votes).

# **NEW BUSINESS**

#### A. PROPOSAL FOR NEW BOILER SYSTEM AT COMMUNITY HALL

Trustee Burkard suggested that if the hall is rented out for summer events some type of air conditioning be installed. It should be advertised on the web site that the hall is available for rent along with a picture when everything is set up with the tables and chairs.

It was MOVED by Trustee Burkard, SUPPORTED by Trustee Voorheis to approve the Proposal for purchase of a New Boiler System at Community Hall. The MOTION PASSED by a voice vote (6 yes votes).

#### B. NEW VEHICLE PURCHASES

It was MOVED by Clerk Lilley, SUPPORTED by Trustee Burkard to approve the purchase of three (3) new vehicles from Signature Ford in the amount of \$76,828. The MOTION PASSED by a voice vote (6 yes votes).

#### C. 2444 PORTER ROAD LEASE

Trustee Burkard asked Trustee Ruggles if he had any financial interest in the Porter Rd. Property that is being leased. He answered no.

It was MOVED by Clerk Lilley, SUPPORTED by Trustee Kowall to allow Trustee Ruggles to abstain from voting on Item 10C. The MOTION FAILED by a roll call vote (Voorheis-yes/Kowall-yes/Baroni-yes/Lilley-yes/Burkard-no).

It was MOVED by Clerk Lilley, SUPPORTED by Trustee Kowall to authorize the Supervisor to proceed with his recommendations, including possibly filing legal action. The MOTION PASSED by a voice vote (6 yes votes).

# D. REZONING - WHISPERING FOREST 13-017

It was MOVED by Clerk Lilley, SUPPORTED by Trustee Burkard to approve the Rezoning of Whispering Forest 13-017. The MOTION PASSED by a voice vote (6 yes votes).

#### E. PRELIMINARY SITE PLAN - WHISPERING FOREST - 13-017

It was MOVED by Clerk Lilley, to approve the Preliminary Site Plan, Whispering Forest - 13-017 with the following requirements: 1. The developer shall install a permanent electrical service to the emergency storm water overflow structure that is sufficient to power a permanent storm water pump station. 2. The developer shall place escrow funds on deposit with the Township, in an amount to be determined by the Township that is sufficient to cover the cost of installing a permanent pump station within the overflow structure. The overflow structure will be constructed during the site development process. 3. Any unutilized escrow funds for the storm water pump station shall be held by the Township until such time as the developer turns control of the association over to the homeowners. From that point forward, these funds shall be used for the installation of a pump (if it has not been previously installed) or for required maintenance of the existing pump and the storm water system.

Trustee Kowall made the following Friendly Amendment to Clerk Lilley's Motion, SUPPORTED by

Trustee Burkard: "The developer shall place escrow funds on deposit with the Township, in an amount to be determined by the Township that is sufficient to cover 15% of the cost of installing a permanent pump station within the overflow structure."

The MOTION PASSED by a voice vote (6 yes votes).

#### F. PARKS & RECREATION - M-59 PEDESTRIAN BRIDGE DESIGN

It was MOVED by Clerk Lilley, SUPPORTED by Trustee Kowall, to approve the request by J&A for their scope of services on File 17518 in the amount of \$17,800 subject to review by MDOT and a finding of no sufficient environmental impact. The MOTION PASSED by a voice vote (6 yes votes).

#### G. 10510 PONTIAC LAKE ROAD

It was MOVED by Trustee Burkard, SUPPORTED by Trustee Ruggles to approve the township attorney moving forward with litigation on 10510 Pontiac Lake Road. The MOTION PASSED by a voice vote (6 yes votes).

#### H. NEW CONTRACT WITH PLANTE MORAN

It was MOVED by Clerk Lilley, SUPPORTED by Trustee Burkard to approve renewing the contract with Plante Moran for five (5) years. The MOTION PASSED by a voice vote (6 yes votes).
