# Approved Minutes of the Regular Board of Trustees Meeting

October 15, 2013

Supervisor Baroni called the meeting to order at 7:00 p.m.

# **PUBLIC COMMENTS**

Bill Chatfield, Director of Operations for Walled Lake School District. He shared some information about the School District's 67.5 million dollar Safety, Security & Technology Bond which will be on the November ballot. This is a parent driven initiative. It is a three phase plan to keep the students safer during the school day. Phase 1 involved locking the doors immediately and hiring door monitors which is an unsustainable expense for the long-term. Phase 2 included installing entrance and buzzer intercom systems. Phase 3 will allow completion of many other safety and security improvements. The average millage rate will be .99 mills which means the owner of a \$200,000 home with a \$100,000 SEV will pay \$99 a year or \$2 a week. Bond monies cannot be used for salaries or general operating expenses.

Jim Runestad, County Commissioner. There will be a tree lighting ceremony on Friday, December 6, from 6 to 9 p.m. This event has previously been at the mall where J.C. Penney is. This year it will be at Fisk Farm. There are many different events, reindeer, Santa, free food such as hot dogs and kettle corn. There is a Facebook page, White Lake Tree Lighting Ceremony, where you can get updates as it gets closer to the event.

Trustee Burkard stated that, as a citizen, she is very happy that the Christmas tree lighting ceremony is taking place on township property. The Fisk Farm is a perfect location to have an old fashioned Christmas event and see what the historical society is doing there. Also, a couple years ago the township turned 175 years old. It was decided that a time capsule would be buried containing items reflecting the history of the township. For any of the young people who are around 50 years from now when the capsule is unearthed you will be amazed at the changes that have taken place.

# A. EXECUTIVE CHEF SHAWN PROCTOR AND SOUS CHEF DAVID LAUTH, JR. OF INDEPENDENCE VILLAGE

Clerk Lilley read into the record a Proclamation recognizing Executive Chef Shawn Proctor and Sous Chef David Lauth, Jr.'s enthusiasm, dedication and extraordinary skills which has contributed to the success of Independence Village, making the residents healthier and happier.

#### B. SWEARING IN OF FIREFIGHTER JULIAN GROSS

Clerk Lilley performed the swearing in of Julian Gross as a new firefighter for the Township of White Lake. He joined the Fire Department in August of 2011. He was raised in Waterford, going to Waterford Kettering High School. He was a cadet with the Waterford Twp. Fire Dept., earning a scholarship to the Oakland Community College Fire Academy. He went on to receive his EMT training with the Waterford Fire Department and is in his last month of the paramedic program with McLaren Hospital in Flint.

#### C. POLICE DEPT. AWARDS AND SWEARING IN

Chief Harris awarded a certificate of appreciation to Dennis McCue, William Tolbert and Fred Mellen for an incident that occurred back on July 3, 2013. Mr. McCue was unloading items from his vehicle when confronted and assaulted by an individual who was trying to take his car keys. He fought back and was aided by Mr. Tolbert and Mr. Mellen. Through their actions these men were instrumental in this felon being brought to justice.

Chief Harris awarded a meritorious service citation to Officer Thomas Sarasin who was dispatched to a residence with an unresponsive woman. When he arrived, he observed the

woman was not breathing and immediately began CPR. He did this until the arrival of fire personnel who then continued lifesaving efforts. His quick action was instrumental in the saving of this woman's life.

Chief Harris presented a certificate of meritorious service lifesaving award to Officer Gregory Hartner and Officer Michael Zorsa who were dispatched to a residence with a suicidal subject. When they arrived, they made contact with an individual who was holding a large knife to his throat. Their calm and quick thinking peacefully ended a tense standoff and prevented the loss of a life.

Clerk Lilley swore in Officer Jessica Snow into service for the White Lake Township Police Department. She successfully completed a lengthy process that includes a written test, a civil service interview, an intense and invasive background investigation and finally medical and psychological exams. She is a 2012 graduate of the Oakland Police Academy. She has an associate's degree from Oakland Community College.
