## A. G.E.M. Discussion

Discussion regarding the recorded Restrictive Covenant dated March 31, 2004 and the water connection agreement dated March 31, 2004. The board discussed several options concerning Mr. Hooper's request. Those options were:

- 1. Simply remove the liens recorded on March 31, 2004
- 2. To require G.E.M. (Mr. Hooper) to pay water lateral fees in the amount of \$5180.75 for parcel 12-22-252-019 and \$419.03 \$491.03 for parcel 12-22-252-014.
- 3. To pay lateral fees in addition to connection fees amounting to:
  - a. 4.7 REU x 2600=12,220.00
  - b. 1.5 " water meter 7,683.00
